(4) Other detailed terms and conditions with regard to the appointment, domicile, reservation, etc.: -

(I) Appointment of the candidates

- (i) The appointment and other service conditions in respect of the candidates selected through this selection process, shall be governed as per extant rules/regulations of SKUAST-J and JKCSR.

(II) Domicile

- (i) The candidate should be a Domicile of the Union Territory of Jammu & Kashmir as defined in terms of the Notifications issued by the Ministry of Home Affairs, Government of India vide S.O 1229 (E) dated 31.03.2020 and S.O 1245(E) dated 03-04-2020 read with Notification issued by the General Administration Department, Government of Jammu and Kashmir vide S.O 166 dated 18-05-2020.

- (ii) The candidate must possess Domicile Certificate issued by the Competent Authority on the format prescribed for the purpose, on or before the cut-off date i.e. last date of submission of online application forms.

(III) Reservation

- i) Reservation for SC/ST/RBA/OSC/PSP/EWS/(ALC/IB) is applicable as per Jammu and Kashmir Reservation Rules-2005 read with S.O. 127 issued by Social Welfare Department, Union Territory of J&K. However, for the vacancies accrued before issuance of S.O 127 dated 20.04.2020, the reservation roster as in vogue at the time of accrual of vacancy for appointment has been applied, in terms of opinion conveyed in the matter by UT Govt. of Jammu and Kashmir.
- ii) Candidates are cautioned to note that in case a claim for reservation is made on the basis of false/fake/fraudulent certificate, he/she shall be debarred from the examination(s) conducted by the university, in addition to any other action as may be deemed appropriate.
- iii) A candidate seeking his/her consideration under Reserved Categories must ensure that he/she possess a valid Category Certificate as on or before the cutoff date of the submission of online application forms. Category certificates issued after the cutoff date shall in no case be entertained.

(5) Important Instructions to the candidates

- The application will be accepted in the prescribed format in online mode only through the University website www.skuast.org. No other means/mode of application will be accepted.
- The last date for receipt of application form as stipulated above, shall be cut off date for determining the eligibility for the post. Any qualification/experience acquired thereafter shall not be considered.
- Applications received without the prescribed fee shall not be considered and shall be summarily rejected. No representation against such rejection will be entertained.
- The selection to the above said advertised posts shall be based only on the written test basis. However, for the posts wherever Skill Test is prescribed for post, it will be only of qualifying nature.
- The syllabus of written test of above said posts shall be notified separately and shall be made available on the University Website: www.skuast.org.
- The applicants shall carefully fill the details in the online application forms and the information/details so submitted shall be treated as final for the purpose of determining eligibility and category of the candidate and no claim, whatsoever in this account shall be entertained subsequently. The candidates are advised to go through the requirements of educational qualification, age, etc. and satisfy themselves that they are eligible for the post(s).
- Only relevant qualification(s) including category status should be recorded in the application form, which shall be in possession of the candidate on or before the last date of submission of the application form.
- The original certificates and testimonials in possession of the candidate on or before the last date of receipt of Application Form(s) together with print out copy of application form submitted online shall be required to be produced by

the applicants at the time of verification of documents, as and when notified by the university.

- In case of candidates claiming possession of equivalent educational qualification (where it is applicable/required), it shall be mandatory to produce relevant Equivalence Certificate from the designated competent authorities at the time of the Document Verification. However, final decision regarding selection of such candidates will be taken by the University, in light of the relevant rules which shall be binding.
- The degree/diploma obtained through distance mode which are in consonance with the Govt. Order No. 252-HE of 2012 dated. 30.05.2012 shall be entertained, subject to fulfilment of other terms and conditions.
- Degree obtained from the Universities declared fake by the University Grants Commission shall not be entertained.
- Canvassing by any candidate in any form will render him/her disqualified for the post.
- The candidates may note that their candidature shall remain provisional until the genuineness of their qualification/category certificate(s) is/are verified by the university.
- The number of post(s) indicated here-in-above is/are tentative and subject to increase or decrease at the sole discretion of the university at the time of appointment.
- The University reserves the right to withdraw or defer filling up of any or all post(s) advertised here-in-above at any stage without assigning any reason(s) thereof.
- The in-service eligible candidate (s) should forward their application forms through their employer. The inservice candidates whose applications are not received through the proper channel shall be considered as fresh candidates and no benefits of previous services shall be granted in their favour. All the in-service applicants are required to produce "No Objection Certificate" from the Competent Authority at the time of documents verification, failing which he/she shall not be considered for appointment as in-service candidate.
- The intending eligible candidates, who wish to apply for more than one post, must submit separate applications forms along with the prescribed fee for each post.
- Candidature of any candidate, found indulging in an irregularity /misconduct/malpractice, at any stage of the selection process, shall be cancelled forthwith and such candidate shall be debarred from the future examinations and any other action as deemed appropriate under rules shall also be taken.
- The candidates shall necessarily indicate their personal valid mobile no and active e-mail address under the relevant column of the online application form for any communication/clarification, from the university, falling which the university shall not be held responsible for any miscommunication.
