Consequent upon the recommendations of the Admission cum Counselling Committee and approved by the competent authority, candidates as per the list (discipline wise) enclosed as **annexure-I** to this notification are granted provisional admission in **M.Sc. Agriculture and Allied Sciences** and **M.Sc. The candidates are advised to report in the office of the Registrar on or before **15-02-2024** during office hours along with the original certificates, two sets of self attested photocopies of testimonials and 5 Passport size photographs (in blue/red background) for filling up of the admission form (**which shall be downloaded from the University website: [www.skuast.org](http://www.skuast.org)**). The candidates thereafter shall report to the concerned Dean of the Faculty for registration in the 1st year, 2<sup>nd</sup> semester of the academic session 2023-24.

The candidates who fail to report for admission in the University by **15/02/2024 up to 5 p.m.**, his/her admission shall be treated as cancelled.
