The produce can be inspected on any working day during office hours except Gazetted Holiday/Saturday/Sunday at Seed Store of Division of Agronomy, Chatha. Terms and conditions:

- 1. Any offer without CDR shall not be entertained.
- 2. The rates should be quoted per quintal basis.
- 3. Conditional bids shall be rejected out rightly.
- 4. The quantities mentioned above are approximate and can vary.
- 5. The bidder can inspect rice grain (Paddy) produce lying at seed store of Division of Agronomy, SKUAST-Jammu, Chatha, on any working day during office hours except Gazetted Holiday/Saturday/Sunday.
- 6. The offer should include cost of gunny bags also.
- 7. Envelope containing the bid amount should be labelled as "Bid for Auction of Rice grains (Paddy) produce".
- 8. 80% amount of accepted bids shall have to be deposited within 3 days of acceptance of the bid and rest 20% before lifting the material.
- 9. The successful bidder shall have to lift the auctioned materials within 5 days of issuance of authorization letter and university shall not be responsible for any kind of damage to the auctioned material whatsoever thereafter.
- 10. The successful bidder who fails to lift the auctioned materials within stipulated time, the next higher bidder shall be offered to lift the material on highest bid.
- 11. The Auction committee reserves the right to accept or reject any tender without assigning any reasons, thereof.
- 12. The disputes, if any, shall be subjected to the jurisdiction of the Hon'ble courts located in the municipal limits of Jammu city only.
